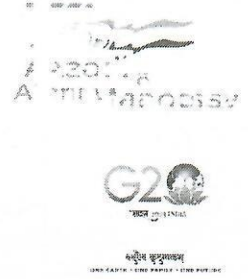

**Sub: Application for letter of permission for functioning of R.N Kapoor Homoeopathic Medical College, Dr. A.P.J Abdul Kalam university campus , Indore – Dewas Bypass Road, Gram Arandia, Madhya Pradesh-452010 for conducting UG (BHMS) course with 100 seats for the academic year 2024-2025 regarding.**

Sir,

R.N Kapoor Homoeopathic Medical College, Dr. A.P.J Abdul Kalam university campus, indore – Dewas Bypass Road, Gram Arandia, Madhya Pradesh-452010 is functional since 2019 and has applied for permission for sanction of **UG (BHMS) course with 100 seats for the academic year 2024-2025**. The college has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the NCH Act 2020.

On careful examination of the Inspection report and Part-1 Information, the Medical Assessment and Rating Board has observed following shortfalls as per MSR requirements:

**a) Teaching Departments:**

- In Community Medicine department, diary and sewage plant visit are pending.
- For 1<sup>st</sup> BHMS- CBDC – no electives are done for both batches.
- In Pharmacy department visit to H.P.L, Noida, New Delhi was not done for both batches.

**b) Miscellaneous**

- No mummified body in the Anatomy department.
- Operation Theatre, X-Ray department, USG department have been established but are non- functional.
- AERB and PNAT were not available.

IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number etc. Diagnosis shall be written as ICD-11 criteria. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients.



Considering the above-observations and facilities available, MARBH has decided to issue **Conditional permission to R.N Kapoor Homoeopathic Medical College, Dr. A.P.J Abdul Kalam university campus , Indore – Dewas Bypass Road, Gram Arandia, Madhya Pradesh- 452010 for conducting UG (BHMS) course with 100 seats for the academic year 2024-2025.**

All deficiency noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the intake capacity of 100 UG seats shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective Counseling authority of State/UT Govt as designated by Central Government/NCH and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

**Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.**
